- **XI.** Displaced Homemaker Program Grantee Reports:

TMCC: Travis Sharpe presented;

Steady increase in new intake with a majority of the referrals being received from Welfare and SNAP. Re-Entry intake also identifies possible DH participants. Travis has recently been visiting the American Job Center in Reno and holding office hours to spread the news about DH and the Re-Entry Program.

Re-Entry has a presence at Opportunity Alliance Nevada weekly on Monday nights in hopes of qualifying more clients for DH. In partnership with JOIN who has just received a Google Grant for computer literacy, resume and interview skills to provide to clients. The Communication Plan solidified intentions for TMCC to provide more outreach to spread the news of DH where case management is provided.

Louise asked Travis why only two exiters? Travis told Ms. Helton that several are close to finding jobs and have great resumes' including a high skilled Executive Assistant at up word of \$28 per hour that has been a bit of a challenge. Next quarter will have improved numbers for exits.

HELP of Southern Nevada: Denise Gee presented

Denise has moved her office into the new West Lake Mead Campus near "I Have A Dream". All of the training staff are located there. Cee Cee is providing workshops at that location Monday – Tuesday.

Wednesdays at south campus in Dual partnership with Sunrise Children's Foundation. Have discussed plans to hire DH clients. Babies First and Las Vegas Diaper Bank support services are available.

Joint partnership was started with Dr. Flowers for basic computer classes at convenient times and at no cost. Classes are paid for by a scholarship and foundation money at HELP. Golden Tickets are put into Holiday bags for those that come in for assistance. The Golden Ticket is redeemed at the office for gift cards as an opportunity to enroll them in the DH Program. Three new clients have been enrolled from the Holiday

Assistance Program. Also Cee Cee has been involved with Foundation for an Independent Tomorrow and a presence at the City Library and City Hall. JobConnect staff come onsite. Denise thanked Odalys for her great feedback during Monitoring. Mary Hausch visited during Open House.

Community Chest: Erik Schoen presented;

Seven new clients Three Exiters More actively pursuing outreach. More sharpened focus to improve. Mineral County – Lovelock – Winnemucca – Dayton – Mineral – Lyon Counties American Job Center Social Justice conference held in September. Nevada Families First – in home case management that Chest helps to provide services. In twenty years in this arena Erick said that he has not seen this dynamics of Consolidations at play. Impressed with the Communication Plan. Next quarter expects to see improvement. A thank you to Odalys and Samantha for input on improving DH file was appreciated.

- XII. Divorce Report Ms. Carmona asked the Board to Table until the next March meeting. Odalys is asking all of the county clerks to provide three figures: number of Divorces, amount of funds collected and the number of waivers. Mary agreed that if an area of waivers can be identified it can be pursued.
