Re: Supplemental Notice re: Suspension of Operations at Hakkasan Nightclub

To Whom It May Concern,

As you know based on prior correspondence, Hakkasan Holdings, LLC, d/b/a Hakkasan Group, 6385 S. Rainbow Blvd., Suite 800, Las Vegas, NV 89118, has halted its operations at Hakkasan Nightclub, located at 3799 S. Las Vegas Blvd., Las Vegas, Nevada, 89109 (inside the MGM Grand Hotel & Casino), on March 13, 2020, due to the unforeseen business circumstances caused by the natural disaster and spread of COVID 19, the Governor of Nevada's declaration of emergency, as well as the recently issued recommendations and/or orders regarding public gatherings by the CDC and various other government agencies and officials. It is anticipated that this cessation of operations of the entire venue will be temporary; however, based on the fluid and rapidly evolving nature of this situation, we are unable to provide a specific date at which we will be able to recommence operations at this time, or to guaranty that we will be able to recommence operations. There are no bumping rights.

As a result of the cessation of operations, 2 individuals who are employed at Hakkasan Nightclub will be laid off effective May 1, 2020. Neither of these employees are represented by a union. This is in addition to the employees previously laid off, of whom you have been previously notified. A list of the job titles of the employees who will be affected, and the number of employees with each job title, is attached.
