*Re: Supplemental Notice of Layoffs – Hakkasan Holdings, LLC Corporate Office*

To Whom It May Concern,

As you know based on prior correspondence, Hakkasan Holdings, LLC, d/b/a Hakkasan Group, 6385 S. Rainbow Blvd., Suite 800, Las Vegas, NV 89118, has laid off certain employees at its corporate office located at the foregoing address, due to the unforeseen business circumstances caused by the natural disaster and spread of COVID 19, the Governor of Nevada's declaration of emergency, as well as the recently issued recommendations and/or orders regarding public gatherings by the CDC and various other government agencies and officials. At this time, given the fluid and rapidly evolving nature of this situation, we do not presently know whether these layoffs will be permanent or temporary in nature, but we anticipate that some, if not all, will be permanent. None of the employees impacted are represented by a union, and there are no bumping rights.

As a result of the foregoing, 26 individuals (including part-time employees) will be laid off effective May 1, 2020 (except for the Benefits Supervisor and 1 of the Payroll Processors, who will be laid off on May 15, 2020). None of these individuals are represented by a union. This is in addition to the employees previously laid off, of whom you have been previously notified. A list of the job titles of the employees who will be affected, and the number of employees with each job title, is attached.
