***Re: WARN Notice for Caesars Linq, LLC***

To Whom it May Concern:

Please accept this letter as notification on behalf of Caesars Linq, LLC (“The LINQ”) that due to the unforeseeable, unanticipated and substantial reduction in business levels resulting from the public health emergency caused by COVID-19, employees at The LINQ, located at 3535 Las Vegas Boulevard South, Las Vegas Nevada 89109, were furloughed starting on or about April 3<sup>rd</sup>, 2020. The LINQ may remain closed for business for the foreseeable future.

This Notice is provided to you in accordance with the Federal Worker Adjustment Retraining Notification Act, 29 U.S.C. §2101 et. seq. (“WARN Act”). This Notice is unfortunately provided less than 60 days before the effective date of the furloughs. While the WARN Act ordinarily requires 60-days advance notice, due to COVID-19, compliance with such requirements was not possible as the furloughs are the result of business circumstances that were not reasonably foreseeable at the time that notice would have been required. Therefore, this Notice is given as soon as practicable under the given circumstances.

A total of 251 employees were furloughed. A list of the job titles of the affected employees is attached, and the number of employees with each job title, is attached.

Caesars Linq, LLC intends for the furloughs to be temporary; however, given the unknown certainty surrounding COVID-19, it is possible that the furloughs could become a permanent layoff. **NON-UNION** Employees will not have the right to bump any employees. No employee is covered by a collective bargaining agreement.

Pursuant to the requirements under the WARN Act, all potentially impacted employees have been notified of the above information as of this date. Presently, we do not need assistance for retraining our employees as we fully intend to re-open with our existing employees. Should circumstances change, we will contact the necessary state and local agencies to provide support as needed.
