Re: Notice of Furloughs

To Whom It May Concern:

This is to notify you pursuant to the Worker Adjustment Retraining and Notification Act (WARN), 29 U.S.C. § 2101, that Global Experience Specialists, Inc. has implemented furloughs at its facility located at 7000 Lindell Road, Las Vegas, NV 89118. Due to the unforeseen business circumstances relating to COVID-19, temporary furloughs began in March 2020. These furloughs are now expected to be indefinite and have affected 339 employees at this location.

As you know, the COVID-19 virus recently reached pandemic proportions and the federal government and many states, including Nevada, have declared a state of emergency and issued business closure and travel restriction orders. These sudden and unexpected circumstances adversely affected our business operations and, unfortunately, prevented us from providing notice sooner.

To the extent the above actions constitute a covered event under the federal Worker Adjustment and Retraining Notification Act, this letter is only intended to fulfill any requirements that may possibly be imposed under the WARN Act. The provision of this information does not mean that the WARN Act applies or that notice is required. This letter is not a contract of any kind.

There will be no bumping rights or bumping procedures since the employees of the Company are not covered by a collective bargaining unit. The following is a list of the positions which have been or will be subject to furlough, as well as the number of employees who currently hold these positions:
