Re: Supplemental Notice of Layoffs – Allegiant Air LLC Headquarters Facility

To Whom It May Concern:

As you know based on prior correspondence, Allegiant Air LLC, 1201 N. Town Center Drive, Las Vegas, NV 89144, has issued layoff notices to certain employees at its corporate headquarters located at the foregoing address. The layoffs were due to the unforeseen business circumstances caused by the impact of the COVID-19 pandemic.

As a result of the continuing impact of the pandemic, 50 additional employees will be laid off effective October 8, 2020. The numbers of employees in the positions impacted are contained in the attached list. These employees are not represented by a union and do not have a seniority bumping system; the layoff is expected to be permanent. These employees are in addition to the employees previously laid off, of whom you were previously notified. We are complying with all provisions of WARN and will pay at least 60 days of notice pay within 21 days of the layoff date. Health benefits in which the employees participated during their employment will be provided with no interruption and at no cost to the laid off employees through December 31, 2020.
