Subject: WARN Act Notification - Reduction-in-Force (RIF) of Combat Tactical Training Range (CTTR) contract personnel.

This notice is being provided pursuant to regulation contained in the Worker Adjustment and Retraining Notification (WARN) Act of 1988, which require affected employers to provide notice to certain government units or officials of a pending mass layoff or permanent closure.

This is to advise you that on May 12, 2020, Amentum, a federal contractor under the Combined Tactical Training Range (CTTR) Systems and Equipment contract may undergo a permanent Reduction in Force affecting approximately four hundred and ninety two (492) exempt, union, and SCA positions at various locations in the states of Arizona, California, Florida, Nevada, New Hampshire North Carolina, South Carolina, Utah, Virginia, and Washington. This action can only be reversed if the U.S. Government extends work under this contract prior to May 12, 2020. See below breakdown of the positions affected in the State of Nevada:
