Re: Notice of Temporary Suspension of Operations at Jewel Nightclub

To Whom It May Concern,

Please accept this letter as notification that Hakkasan Holdings, LLC, d/b/a Hakkasan Group, 6385 S. Rainbow Blvd., Suite 800, Las Vegas, NV 89118, temporarily halted its operations at Jewel Nightclub, located at 3730 S. Las Vegas Blvd., Las Vegas, Nevada, 89109 (inside the ARIA Hotel & Casino), on March 13, 2020, due to the unforeseen business circumstances caused by the natural disaster and spread of COVID 19, the Governor of Nevada's declaration of emergency, as well as the recently issued recommendations and/or orders regarding public gatherings by the CDC and various other government agencies and officials. It is anticipated that this cessation of operations of the entire venue will be temporary; however, based on the fluid and rapidly evolving nature of this situation, we are unable to provide a specific date at which we will be able to recommence operations at this time. We have temporarily ceased operations of the entire venue; thus, there are no bumping rights.

As a result of the temporary cease in operations, approximately 130 individuals (including part-time employees) who are employed at Jewel Nightclub will be put into layoff status. A list of the job titles of the employees who will be affected, and the number of employees with each job title, is attached.
