Dear Mr. Reed:

As you are aware, the President has declared a national state of emergency and state and local officials across the country have issued public health orders to prevent the spread of the Coronavirus. The Coronavirus pandemic is a natural disaster and physical calamity which has created a reasonably unforeseen business circumstance under the Worker Adjustment and Retraining Notification ("WARN") Act of 1988. In order to ensure that you, all employees, and their representatives receive as much notice as possible, Prospect Airport Services, Inc. ("Company") is providing notice to you and each impacted employee at the following affected location:

McCarran International Airport ("LAS") 5757 Wayne Newton Blvd. Las Vegas, NV 89119

Regrettably, the Company began laying off employees at the LAS location as of March 21, 2020. Additional layoffs may continue for 30 to 60 days thereafter scheduled in response to airline industry demands which are fluid at this time. It is the Company's hope that these layoffs will not affect all LAS operations and will only be temporary in nature. However, due to the unprecedented nature of the pandemic, the Company cannot guarantee any timeline for recall, if employees will be recalled.

Be advised that there are no bumping rights as a result of this layoff.
