This notice is being issued by DynCorp International LLC (DI) in accordance with the Worker Adjustment and Retraining Notification Act (WARN).

To date, DI has not been awarded the new contract supporting the Naval Air Warfighting Development Center (the NAWDC Contract). As a result, DI's operations at Fallon, NV will close and the employment of all DI employees performing on the NAWDC Contract is expected to end on January 31, 2021. Employment may end sooner based on direction from our customer the U.S. Navy.

All affected employees have been notified. A list of the job titles of the positions affected and the number of affected employees in each job classification appears below.

Bumping rights do not exist for any employee. Please note, however, that the F-16 Platform work currently performed by DI on the NAWDC Contract will continue to be performed by a successor contractor, Vertex. We anticipate that Vertex will be communicating with the DI NAWDC workforce about employment opportunities in the near future. Additionally, DI expects to be awarded a Bridge Agreement to continue to support the F-18, SH-60 and E-2 work. In the event DI is awarded the Bridge Agreement, all lay-off activities will cease.

DI is a party to a CBA with the Industrial Division of the Communications Workers of America AFL-CIO-CLC Local Lodge 89119. The name and address of the chief elected officer of this Union is:
