I. CALL TO ORDER – Dennis Perea

Due to video-teleconferencing difficulties, Dennis Perea, Co-Chair of the WIOA Governance Workgroup, requested Steve Fisher to act as Chair in his behalf. Mr. Fisher called the meeting to order at 9:07 a.m.

II. ROLL CALL- CONFIRMATION OF QUORUM – Coralie Peterson

Coralie Peterson called roll and confirmed that a quorum for the meeting was present.

III. VERIFICATION OF PUBLIC NOTICE POSTING – Coralie Peterson

Ms. Peterson verified that the agenda and notice for today's meeting was posted pursuant to NRS 241.020.

IV. FIRST PUBLIC COMMENT(S) – Dennis Perea

Members of the public are invited for comment(s). **NO** action may be taken on a matter during public comments until the matter itself has been included on an agenda as an item for *possible action*, and properly noticed pursuant to **NRS 241.020**. Steve Fisher announced the First Public Comment Session and invited members of the public to speak. No comments were made. Hearing none, Mr. Fisher moved to the next agenda item.

V. **DISCUSSION/FOR POSSIBLE ACTION:** APPROVAL OF MINUTES: GW meeting held on June 26, 2015 – *Dennis Perea*

Dennis Perea said that this item would be tabled and would be addressed in the next GW meeting.

VI. **DISCUSSION/FOR POSSIBLE ACTION:** APPROVAL AND ADOPTION OF BY-LAWS FOR WIOA IMPLEMENTATION AND PLANNING MEETINGS – *Steve Fisher*

Mr. Fisher asked for the workgroup members to comment on the By-Laws draft. Renee Olson stated that she felt that the title of the group in Article I should be changed to WIOA Implementation Planning as they will be planning and not implementing. She also added that she had a concern about the makeup of the team itself representing business sufficiently. John Thurman commented that the rules of the Board may not pertain to the committee itself. Dennis Perea added that representation would be good, and suggested that volunteers could be asked to join. Britta Kuhn stated that the draft is good and should allow for flexibility.

- Renee Olson raised a motion to modify the name of the WIOA Implementation and Planning Team shown in Article I of the By-Laws to the WIOA Implementation Planning Team *and to* change Article III of the By-Laws to provide policy guidance and strategic program design structure that will be used to develop a Combined Plan based on the requirements set forth in the Workforce Innovation and Opportunity Act. Britta Kuhn seconded her motion. All were in favor and the motion carried unanimously.
- Michael Raponi then raised a motion that the title of the WIOA Implementation and Planning Team
 be changed to WIOA Implementation Planning Team and Ardell Galbreth seconded this motion. All
 were in favor and the motion carried unanimously.
- VII. **DISCUSSION/FOR POSSIBLE ACTION:** DISCUSSION OF RESPONSES AND SUGGESTIONS FOR EACH PROGRAMS' TOP 3 QUESTIONS AND REVIEW OF ASSET MAPPING DOCUMENT *Shelley Hendren*

Dennis Perea stated he provided the workgroup members a list of questions to provide a start of their discussion of the top questions for each program. Shelley Hendren and Steve Fisher commented that they too had additional questions. Mr. Fisher agreed to provide a complete list for the following meeting.

• Dennis Perea raised a motion to approve that the complete list of top questions be approved to go on to the full committee, and that additional questions that are sent on to the GW can be discussed in the next meeting. Britta Kuhn seconded his motion. All were in favor and the motion carried unanimously.

VIII. **DISCUSSION/FOR POSSIBLE ACTION:** REVIEW AND APPROVAL OF OPERATIONAL RULES AND BY-LAWS FOR MONTHLY TEAM MEETING – *Dennis Perea*

Mr. Perea deleted this agenda item.

IX. **DISCUSSION/FOR POSSIBLE ACTION:** MEASUREMENT METHODOLOGIES – *Steve Fisher*

Should the Performance Accountability Workgroup develop meaningful measurements in addition to the Federal Measurements?

Dennis Perea tabled this agenda item as this topic has been referred to the WIOA Performance Workgroup team for discussion.

X. **DISCUSSION/FOR POSSIBLE ACTION:** AFFILIATE SITE(S) DEFINITION – Dennis Perea

Dennis Perea asked for comments on the definition of affiliate sites. Grant Neilson said that the consensus is that it should mirror WIOA Sections 6, 7, 8, 310. and 315, showing what an affiliate is and does, which basically precludes affiliate sites.

Dennis Perea stated that they should determine whether they were working for compliance or to change the system (customer service delivery system.) Renee Olson said that they need to look at what would make the system work. Mr. Perea went on to state the far-reaching ramifications, and that compliance may mean no change would take place. Discussion ensued amongst workgroup members about of having the participation of rural areas of the state. Mr. Perea stated that all areas should expect to get a certain level of services, and only the programs themselves can describe the services that they provide.

Lynda Parven commented that there may be a concern about the cost of providing staff at each office. Mr. Perea said that the highest level of service should be provided, whether in rural or metropolitan areas, without overtaxing their resources (referral services were noted), but that a middle ground should be their goal, not a minimal standard.

Grant Neilson commented that his workgroup will put forth policy recommendations.
