Chair Hooks announced the First Public Comment Session and invited members of the public to speak. No comments were made. Hearing none, he proceeded to the next agenda item.

4. For Possible Action - Approval of the July 11, 2017 Commission Meeting Minutes - Kevin E. Hooks, Chair

Chair Hooks asked if all had an opportunity to review the meeting minutes.

**Commissioner Tiffany Young** drew attention to the first item showing as Call to Order, Kevin Hooks, and that she had actually served as the acting chair for the July 11, 2017 meeting, which Chair Hooks affirmed this and noted that this would be shown correctly.

Charlotte Centuori made a motion to approve the minutes and Sean Higgins seconded the motion. None were opposed and the motion carried unanimously.

Chair Hooks stated that they would move forward into the Public Hearing item. He then welcomed Sophia Long to comment.

**Deputy Attorney General Sophia Long** greeted the commission members and introduced herself, who was present for the Petitioner. She went on to explain that seated adjacent to her were Kara Jenkins, NERC Administrator, Petitioner in this action, and seated to her left was Mary Chapman, who is the attorney for the Respondent.

She stated that pursuant to NRS 622 A, today, the parties have agreed to present the proposed settlement to the Commission in lieu of the hearing. Ms. Long confirmed that all had reviewed the settlement agreement.

Commissioner Sean Higgins stated that he wish to disclose for the record that he has known one of the Respondents, Mr. Moshe Rosenbloom, for twenty-seven years. He went on to say that he did not, either currently or in the past, have any business dealings with him, and did not feel that his relationship with Mr. Rosenbloom would affect his ability to be an impartial commissioner at this hearing. He asked if this was sufficient disclosure.

Both Chair Hooks and Deputy Attorney General Long affirmed this and thanked Mr. Higgins for his disclosure.

Deputy Attorney General Long then commented that this was a fair and equitable settlement, good for all parties, and requested that the Commission formally accept the agreement.

**Commissioner Higgins** stated that the settlement sets forth certain requirements and asked if they were authorized to impose any other disciplinary action/fines should they Respondents not live up to the agreement, or would they need to have another hearing.

Ms. Long confirmed that they would need to have another hearing, and in addition, the Commission does not have the authority to issue any other fines or anything above the Cease and Desist instruction.
