## NOTICE OF INTENT TO ACT UPON A REGULATION

Notice of Hearing to adopt the amended Regulations related to the Veterans & Senior Citizens Small Business Loan Program Post Date: 2/11/2020

The purpose of the hearing is to receive comments from all interested persons regarding the proposed amendment to the Regulation pertaining to Nevada Administrative Code (NAC) 612. These amendments will do the following:

- Increase the limit for reimbursement of administrative costs incurred as a result of administering a loan under the program from ten to twenty percent of the total amount of all grants awarded to the nonprofit private entity for the purposes of making loans under the program.
- Add a requirement that financial institutions entering into a contract to disburse a grant of money to a qualifying non-profit entity through the program distribute that money no later than 15 months after the grant is approved.

## NOTICE AND EXPLANATION

The purpose of the hearing is to receive comments from all interested persons regarding the amendment of a Regulation that pertains to Chapter 612 of the NAC.

The following information is provided pursuant to the requirements of NRS 233B.0603:

- 1. Statement of the need for and purpose of the proposed regulation or amendment
  - NAC 612.685
    - This regulation will increase the allowable percentage for reimbursement of administrative costs pursuant to NRS 612.607 from 10% to 20%. This regulation is needed to increase industry interest in partnership for administering this program.
  - NAC 612.673
    - This regulation will add a requirement to the Veterans and Senior Citizens Small Business Loan Program stating that financial institutions entering into a contract to disburse a grant of money pursuant to the program shall distribute the funds within 15 months of the date on which the application for the grant submitted by the nonprofit private entity is approved. This regulation is needed due to standard bank lending practices making it untenable for the awarded party to implement any program or report on any program activity under previous timelines.

- This regulation will increase the allowable percentage for reimbursement of administrative costs pursuant to NRS 612.607 from 10% to 20%.
- NAC 612.673
  - This regulation will add a requirement to the Veterans and Senior Citizens Small Business Loan Program stating that financial institutions entering into a contract to disburse a grant of money pursuant to the program shall distribute the funds within 15 months of the date on which the application for the grant submitted by the nonprofit private entity is approved.

• The immediate impact of this regulation will be an addition of a requirement for grant funds to be issued pursuant to the Veterans and Senior Citizens Small Business Loan program within 15 months after the approval of the grant.

 By increasing the rate of reimbursement for administrative costs incurred by lenders administering loans pursuant to subsection 2 of NAC 612.683, more non-profit lenders will be attracted to applying to run loans pursuant to subsection 2 of NAC 612.683.

• By requiring that funds for the Veterans and Small Business Loan program be distributed within 15 months of the date the award was approved, the awarded party will be better able to implement programs and report on program activity, which was untenable due to standard bank lending practices prior to the passing of this regulation.

#### 12. Subsection 2 of NRS 233B.064

"Permanent regulation: Prohibition against adoption until text approved or revised by Legislative Counsel; agency to provide written notification to Legislative Counsel of date of adoption; agency to issue statement of reasons for adoption upon request.

1. An agency shall not adopt, amend or repeal a permanent regulation until it has received from the Legislative Counsel the approved or revised text of the regulation in the form to be adopted. The agency shall immediately notify the Legislative Counsel in writing of the date of adoption of each regulation adopted.

2. Upon adoption of any regulation, the agency, if requested to do so by an interested person, either before adoption or within 30 days thereafter, shall issue a concise statement of the principal reasons for and against its adoption, and incorporate therein its reason for overruling the consideration urged against its adoption."

AUTHORITY: §1, NRS 612.607.

A REGULATION relating to unemployment compensation; increasing the maximum amount which the Administrator of the Employment Security Division of the Department of Employment, Training and Rehabilitation may reimburse to a nonprofit private entity for the costs of administering loans to assist certain start-up businesses; and providing other matters properly relating thereto.

#### Legislative Counsel's Digest:

Existing law authorizes the Administrator of the Employment Security Division of the Department of Employment, Training and Rehabilitation to expend money in the Unemployment Compensation Administration Fund to establish a program to provide grants of money to a nonprofit private entity to be used to make loans of money to veterans and senior citizens to start small businesses. (NRS 612.607)

Existing regulations provide that, under certain circumstances, a nonprofit private entity may be entitled to reimbursement for costs of administering a loan under the program. (NAC 612.685) This regulation increases the maximum allowable amount of such reimbursement.

Section 1. NAC 612.685 is hereby amended to read as follows:

612.685 1. If the amount of interest collected by a nonprofit private entity is insufficient

for the purpose of administering loans pursuant to subsection 2 of NAC 612.683, the nonprofit

private entity may be entitled to reimbursement for administrative costs incurred as a result of administering a loan under the program, but any such reimbursement must not exceed [10] 20 percent of the total amount of all grants awarded to the nonprofit private entity for the purposes of making loans under the program.

- 2. A claim for reimbursement pursuant to subsection 1 must be made:
- (a) In accordance with generally accepted accounting principles; and
- (b) On a form prescribed by the Administrator.

# PROPOSED REGULATION OF THE ADMINISTRATOR OF THE EMPLOYMENT SECURITY DIVISION OF THE DEPARTMENT OF EMPLOYMENT, TRAINING AND REHABILITATION

AUTHORITY: §1, NRS 612.607.

A REGULATION relating to economic development; prescribing the time by which certain grants must be disbursed; and providing other matters properly relating thereto.

#### Legislative Counsel's Digest:

Existing law requires each employer to make payments at certain rates into the Unemployment Compensation Administration Fund for the program for the employment and training of unemployed persons and persons employed in this State. (NRS 612.606, 612.607) Existing law authorizes the Administrator of the Employment Security Division of the Department of Employment, Training and Rehabilitation to use that money paid into the Fund to establish a program to provide grants of money to a nonprofit private entity to make loans to veterans and senior citizens to start small businesses. (NRS 612.607) Existing regulations set forth requirements for the program, including the application for, and awarding of, grants to nonprofit private entities for the purpose of making loans for certain start-up businesses of veterans and senior citizens. (NAC 612.673-612.685) This regulation requires any financial institution that enters into a contract to disburse grants of money to a nonprofit private entity through the program to disburse the grant to the nonprofit private entity not later than 15 months after the date on which the application for a grant submitted by the nonprofit private entity is approved by the Administrator.

Section 1. NAC 612.673 is hereby amended to read as follows:

612.673 1. The Administrator shall establish a program to disburse grants of money to

nonprofit private entities organized under the provisions of chapter 81 or 82 of NRS to be used

exclusively to assist start-up businesses which are at least majority owned and controlled by one or more veterans or one or more senior citizens.

2. Any financial institution that enters into a contract to disburse a grant of money to a nonprofit private entity through the program shall disburse the grant to the nonprofit private entity not later than 15 months after the date on which the application for the grant submitted by the nonprofit private entity pursuant to NAC 612.677 is approved by the Administrator.
