Counties and Cities Employment & Unemployment Overview

March 2023

Published on April 25, 2023

In March 2023, the seasonally adjusted unemployment rate in Nevada was unchanged and still sits at 5.5 percent. The unadjusted unemployment rate decreased slightly, going from 5.7 percent to 5.4 percent for a decrease of 0.3 percentage points. As has been the case with previous months, the labor force in the state grew. However, unlike in previous months, the number of unemployed individuals decreased whereas the number of employed individuals still increased. The labor force grew by 1,895 people in total, with an increase of 2,345 employed people and a decrease of unemployed of 450.

At the MSA (Metropolitan Statistical Area) level, the state saw decreases in unemployment rate across all three MSAs. In the Reno-Sparks and Carson MSAs, there was a decrease equivalent to 0.1 percentage points, with them now sitting at rates of 4.4 and 5.1 percent, respectively. The Las Vegas MSA also saw a decrease, with it's drop being 0.3 percentage points, down to 5.7 percent. These figures are not seasonally adjusted


At the county level, the state saw a similar trend with all counties seeing decreases in unemployment rate. The largest decreases were in Eureka and Mineral county, with decreases of 0.9 percentage points and 0.6 percentage points respectively. The smallest decreases were in Carson City, and Washoe and White Pine County, with all only seeing decreases of 0.1 percentage points.

Figures for state unemployment estimates come from the Local Area Unemployment Statistics (LAUS) program, a state/federal partnership sponsored by the Bureau of Labor Statistics (BLS-LAUS). This program produces monthly and annual employment, unemployment, and labor force data for census regions, states, counties, metropolitan areas, and many large cities, based on place of residence. 

Seasonally adjusted estimates account for regularly seen seasonal employment patterns such as jobs associated with holiday hiring, holiday and weather seasons, or other jobs with seasonal components. The result of a seasonally adjusted estimate is usually a smoother estimate from which underlying economic trends can be seen. Adjusted estimates are in the summary table above, and in many of the other tables and figures throughout this document.

Nevada's seasonally adjusted unemployment rate was 5.5 percent in March, which was unchanged from 5.5 percent in February, and increased by 0.2 percentage point from 5.3 percent in 2022. The number of unemployed individuals decreased by 450 from February for a current level of 86,661 people, which increased by 6,001 unemployed people since 2022. The labor force in Nevada is currently 1,572,641 people, which has increased by 1,895 people from February, and increased by 44,358 people since 2022.




The Las Vegas Metropolitan Statistical Area's (MSA)s unemployment rate was 5.7 percent in March 2023, decreasing from 6 percent in February 2023, and down from 5.9 percent in March 2022, non-seasonally adjusted. The number of unemployed individuals decreased by 3,562 since February 2023 for a current level of 66,396 people, which is 209 less unemployed people than March 2022. The labor force in Las Vegas is currently 1,163,562 people, which is 1,334 less people than February 2023, and is up 37,724 people since March 2022.





The Reno MSA's unemployment rate was 4.4 percent in March 2023, decreasing from 4.5 percent in February 2023, and up from 3.1 percent in March 2022, non-seasonally adjusted. The number of unemployed individuals decreased by 293 since February 2023 for a current level of 11,610 people, which is 3,803 more unemployed people than March 2022. The labor force in Reno is currently 264,723 people, which is 1,282 less people than February 2023, and is up 9,245 people since March 2022.

The Carson City MSA's unemployment rate was 5.1 percent in March 2023, decreasing from 5.2 percent in February 2023, and up from 3.6 percent in March 2022, non-seasonally adjusted. The number of unemployed individuals decreased by 31 since February 2023 for a current level of 1,319 people, which is 416 more unemployed people than March 2022. The labor force in Carson City is currently 25,870 people, which is 2 less people than February 2023, and is up 999 people since March 2022.


Unemployment Insurance Benefits

In March 2023, 9,639 initial claims for unemployment insurance were filed in Nevada, an increase of 550 claims, or 6 percent, from April when there were 9,089 claims. As both the labor market and hiring remain strong in the state, the number of claimants continues to fall. Currently, both initial and continued claim levels are below pre-pandemic levels and continue to inch lower each week. Looking forward, continued claim levels should level off or decline slightly, as many of those continuing to claim benefits are the ones likely experiencing the greatest challenges re-entering the labor force.

The statewide decrease in continued claims over-the-year can be attributed to the large decreases realized in Clark and Washoe counties. Continued claim levels continue to inch lower in each county this month to levels not seen in a couple decades. While continued claim numbers have appeared to level off, the number of claimants will likely continue to decline as more constituents re-enter the labor market.

Within the states' 17 counties, initial claim levels were relatively stable, moderately increasing or decreasing over each report week this month. For the last report week in March, Washoe's initial claims decreased by 71 (-21%) claims, the largest decline realized in all the counties in the state.


Furthermore, for the report week ending March 25, 2023, continued claim levels carried on an upward trend in two of the three metro areas, Carson City and Washoe County, and a downward trend in the last metro area, Clark County. In Carson City and Washoe County, an increase of 38 (10%) and 250 (9%) claims were realized, respectively. The last metro area, Clark County, realized a decrease in 405 (-3%) continued claims.

Source: DETR Internal Reporting Figure 11 Looking at other measures of unemployment insurance activity, most counties' final payments slightly increased or remained unchanged from last month aside from Carson City, Elko, Nye, and Pershing counties. Washoe County realized the largest increase (31) in final payments over the month. First payments increased or remained unchanged in most counties in March 2023 as well. However, Clark decreased first payments by 290. Additionally, most counties realized a decrease in benefit payments over the month with Clark decreasing by \$640,801 (-3%) while Washoe increased benefit payments by \$326,910 (6%).
