April unemployment continues to decline in several areas in Nevada

According to the Department of Employment, Training and Rehabilitation's ([DETR](#)) March 2021 economic report, Nevada's seasonally adjusted unemployment rate was 8.1 percent in March 2021, decreasing from 8.4 percent in February 2021, and up from 6.4 percent in March 2020. Seasonally adjusted estimates account for regularly seen economic patterns, and the rest of the estimates in the release have not been seasonally adjusted.

In the three Metropolitan Statistical Areas (MSA), the unemployment rates were 8.8 percent in the Las Vegas area, 4.6 percent in Reno, and 5.1 percent in the Carson area in March 2021.

In Nevada's counties the lowest unemployment rate was in Eureka County at 2.3 percent, while Clark County had the highest rate at 8.8 percent. Since March 2020, all county's unemployment rates decreased over the year, besides Clark County's. Compared to the national unadjusted rate of 6.2 percent, only Clark County had an unemployment rate higher than the national average. Nevada Local Area Labor Market Overview

March 2021

Published on April 20, 2021

March's unemployment generally improved when compared to February 2021, but still is up from March 2020. The state has an unemployment rate of 8.1 percent when accounting for seasonal patterns which is higher than the national rate of six percent. Within the state, rates ranged from 2.3 percent in Eureka County to 8.8 percent in Clark County. Within Clark County the city North Las Vegas has the highest unemployment rate in the state at 10 percent. It is important to note that the 2020 annual benchmark revision process in Nevada and its substate areas has concluded and is reflected in this month's report.

When looking at unemployment claims in March there were slight increases in many of the state's counties that is likely in line with seasonal patterns. In March, there were 42,498 initial claims in Nevada an increase of 8,620 claims, or 25.4 percent, from February when there were 33,878 claims, but down from a high of 208,869 claims in March 2020. Most claims were in the Clark County area.

Figures for our unemployment estimates come from the Local Area Unemployment Statistics (LAUS) program, a state /federal partnership sponsored by the Bureau of Labor Statistics ([BLS-LAUS](#)). This program produces monthly and annual employment, unemployment, and labor force data for census regions, states, counties, metropolitan areas, and many large cities, based on place of residence. 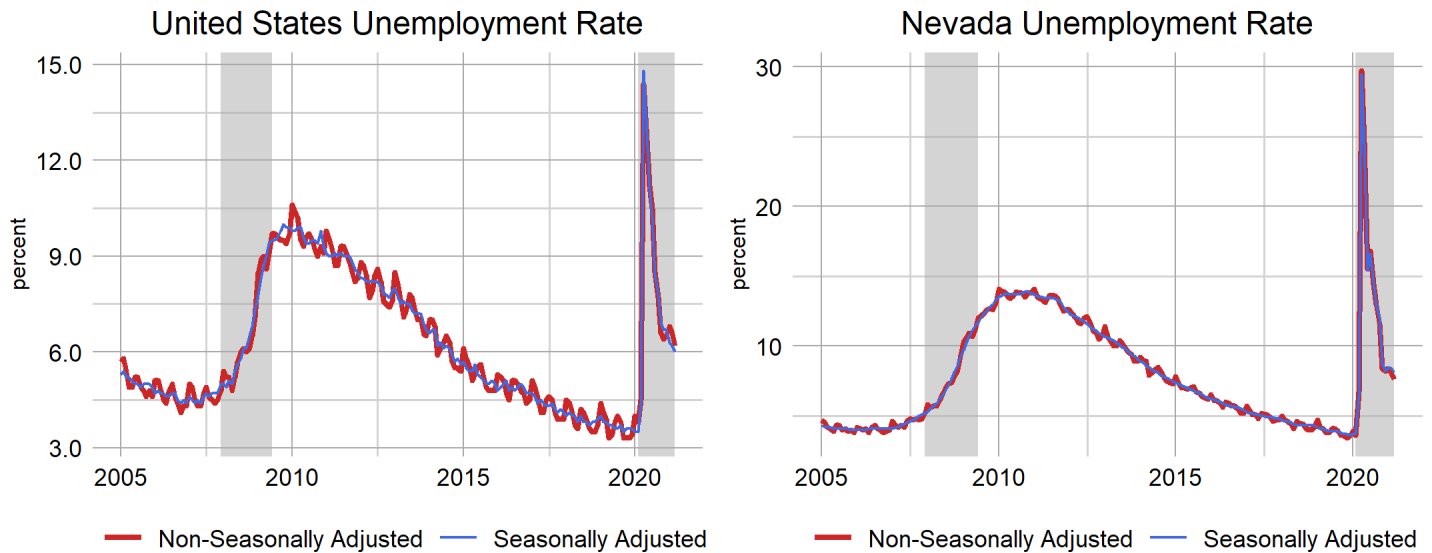

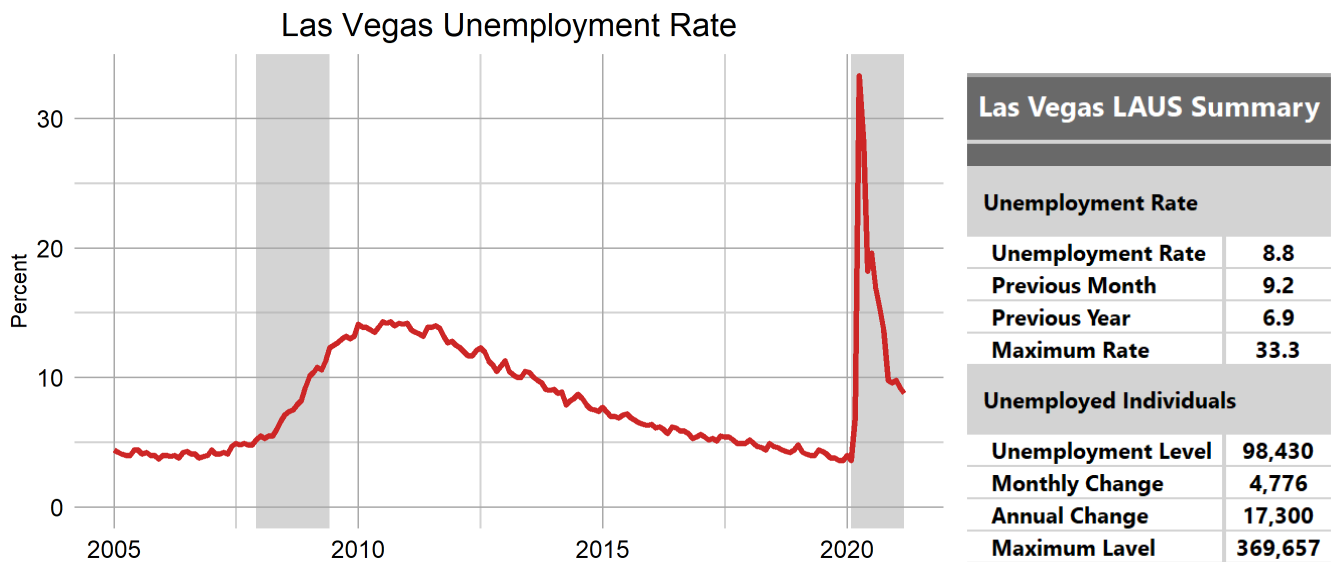

Seasonally adjusted estimates account for regularly seen seasonal employment patterns. Things like holiday hiring, beach season, ski season, or other jobs with seasonal components. The result of a seasonally adjusted estimate is usually a smoother estimate from which underlying economic trends can be seen. Adjusted estimates are in the summary table above, and in many of the other tables and figures through this document.

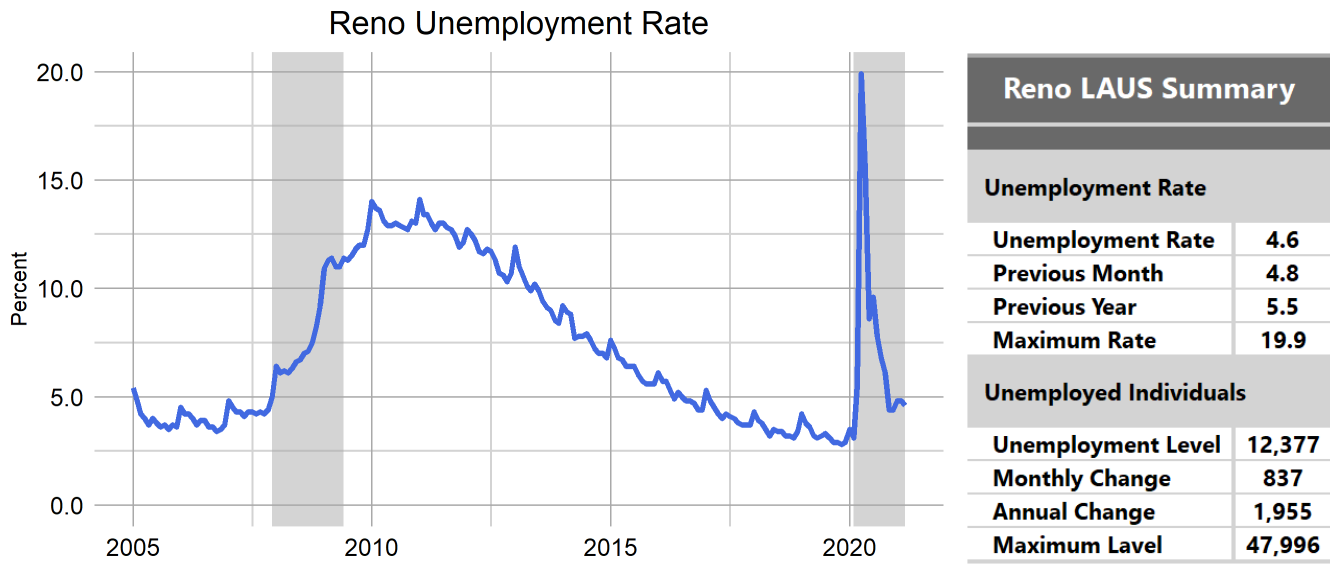
Nevada’s unemployment rate was 8.1 percent in March 2021, decreasing from 8.4 percent in February 2021, and up from 6.4 percent in March 2020, seasonally adjusted. The number of unemployed individuals decreased by 4,238 since February 2021 for a current level of 126,356 people, which is 24,267 more unemployed people than March 2020. The labor force in Nevada is currently 1,552,901 people, which is 5,645 more people than February 2021, and is down 34,999 people since March 2020.



The Las Vegas MSA’s unemployment rate was 8.8 percent in March 2021, decreasing from 9.2 percent in February 2021, and up from 6.9 percent in March 2020, non-seasonally adjusted. The number of unemployed individuals decreased by 4,776 since February 2021 for a current level of 98,430 people, which is 17,300 more unemployed people than March 2020. The labor force in Las Vegas is currently 1,117,466 people, which is 3,217 less people than February 2021, and is down 50,664 people since March 2020.



The Reno MSA's unemployment rate was 4.6 percent in March 2021, decreasing from 4.8 percent in February 2021, and down from 5.5 percent in March 2020, non-seasonally adjusted. The number of unemployed individuals decrease by 837 since February 2021 for a current level of 12,377 people, which is 1,955 less unemployed people than March 2020. The labor force in Reno is currently 270,600 people, which is 2,005 less people than February 2021, and is up 9,138 people since March 2020.



The Carson City MSA's unemployment rate was 5.1 percent in March 2021, decreasing from 5.4 percent in February 2021, and down from 6.9 percent in March 2020, non-seasonally adjusted. The number of unemployed individuals decreased by 102 since February 2021 for a current level of 1,388 people, which is 447 less unemployed people than March 2020. The labor force in Carson City is currently 27,285 people, which is 107 less people than February 2021, and is up 610 people since March 2020.

Unemployment Insurance Benefits (U)

Initial claims for unemployment insurance totaled 42,498 statewide in March 2021, up 25.3 percent from February. With many claimants having begun filing for unemployment insurance benefits in March of 2020, this month saw the end of the benefit year for those claimants. Those claimants were required to file a new initial claim for the new benefit year and is likely the primary driver of the month-over-month increase. Some of these new filings may have been classified as a transitional initial claim and are not counted in our monthly claims total. These transitional claims are included in our county data.

At the county level, increases in initial claims were seen in every county in the state. Much of this increase in activity was driven by the new claim year. Continued claims for the regular unemployment insurance, which are a proxy for the number of persons filing for regular benefits in a given week, were largely unchanged in the month. Only a handful of counties, including Humboldt, Lander, Washoe, and White Pine, saw increases in activity over the month. Continued claims levels have been more stable in the recent months as most of Nevada's claimants are receiving benefits from the pandemic extension programs.

Looking to other measures of unemployment insurance activity, we saw sizable increases across most counties in the number of first payments, though this is likely related to our increase in initial claims. Final payments, also known as exhaustions, fell in nearly every county. Payments in the regular program also fell in nearly every county. This was led by Clark County which saw benefit payments fall by \$17 million compared to February's total. It should be noted that most of Nevada's claimants have already exhausted their regular program benefit weeks and are likely receiving pandemic extension program benefits.

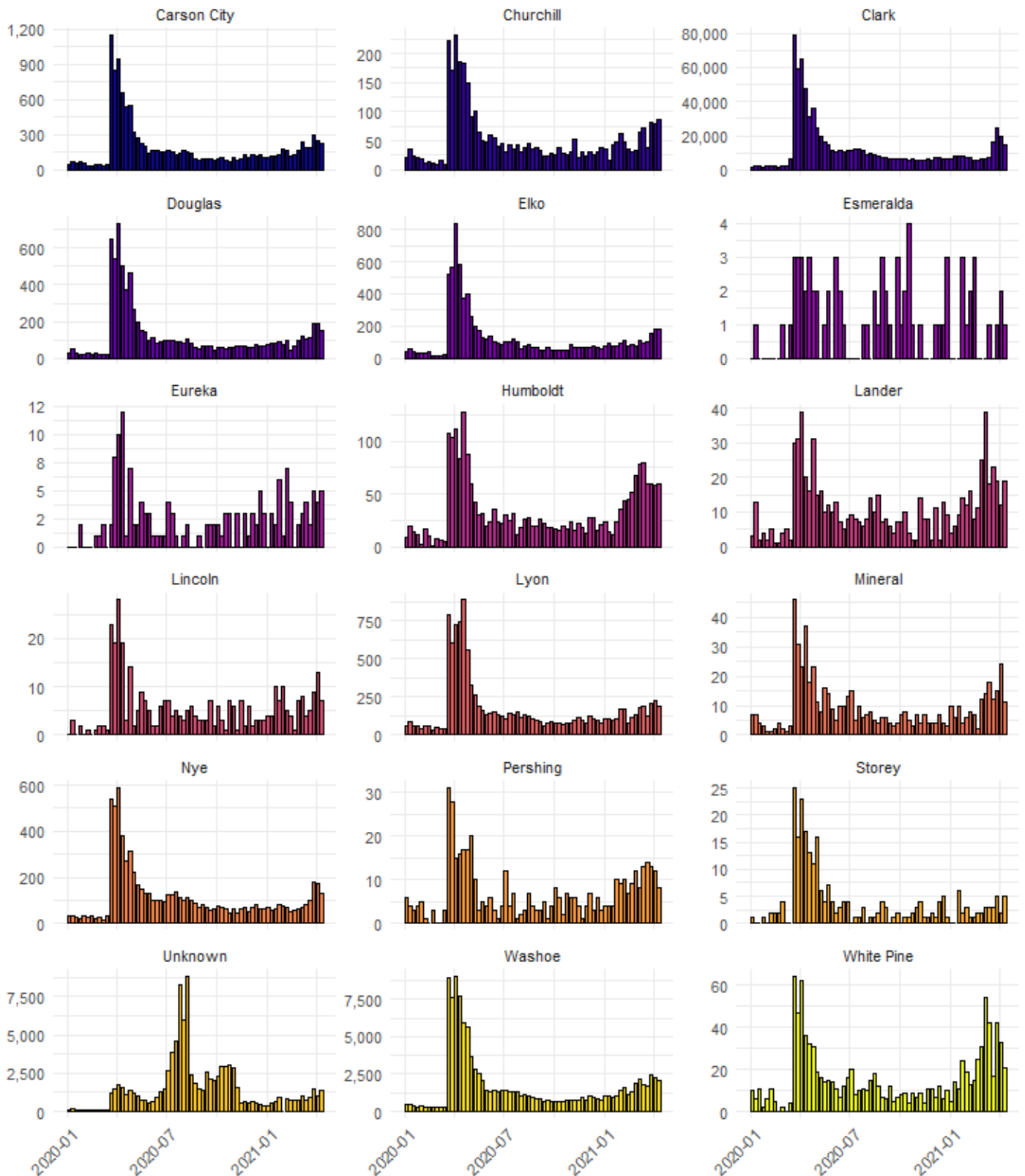

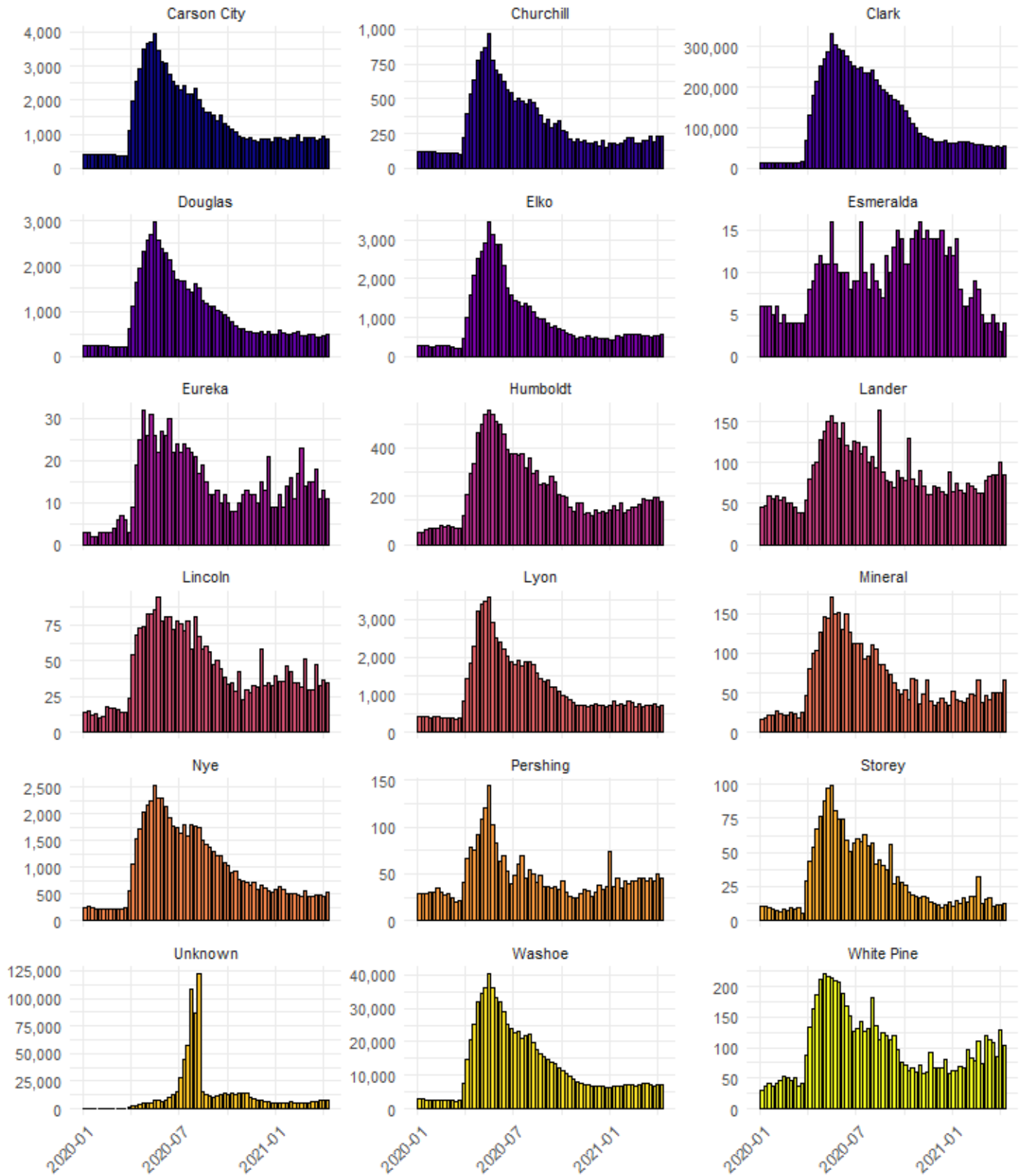
Initial Claims by County
