Dear Ms. Morgando:

I am enclosing herewith my CV which sets forth my legal experience over the past 35 years.

I have been acting as a Hearing Officer in the Department of Administration in a part time capacity since being appointed, in 2014, by Governor Sandoval. In that time, I have acted as Hearing Officer in a number of fair hearings involving the Bureau of Vocational Rehabilitation. The law governing the provision of vocational rehabilitation services in the state of Nevada is set forth in Chapter 615 of the Nevada Revised Statutes, the regulations promulgated thereunder set forth in NAC Chapter 615, and federal laws related to vocational rehabilitation programs. In the course of my practical experience, I familiarized myself with the legislation, the legislative intent, and the interpretive case law.

Overriding any decision involving vocational rehabilitation is the legislative intent, which is to provide vocational rehabilitation services to individuals with disabilities, so that they may prepare for and engage in competitive and integrated employment.

Fair hearings involving these matters can be challenging, as there is no method of appointing counsel. Typically, the disabled individual presents their case in proper person. It does take a measure of patience and skill to direct these fair hearings and to insure that persons untrained in the law have the full opportunity to be heard and express their positions, while maintaining some measure of focus and fairness to the agency.

My adult son is on the spectrum and I have a special affinity for these cases and the laudable intent of the legislation. I hope to be able to continue to serve.
